In its aspiration to provide the most advanced electronic services to its customers, the Qatar Council for Healthcare Practitioners is delighted to launch an electronic copy of the license (E-license) that will enable healthcare practitioners to access their valid license through the Electronic Registration & Licensing system or through smart phones and tablets. As shown below:

- 1- The practitioner can start working immediately once the E-license is issued and they will get notified through the registration & Licensing system.
- 2- The E-license can be used as a reference during inspection or to be presented to the public.
- 3- The license will be accompanied with a QR code which can be scanned by mobile devices and smart phones to ensure its integrity.
- 4- Valid electronic license will be available for anyone who wants to search for a licensed practitioner which will show his employer and scope of practice.
- 5- The E-license will only be available as long as the practitioner's registration is valid. On the expiration of the license, it will no longer be viewable on the system.

Please note that practitioners still have to receive their physical card and until further notice.

The mentioned above will be effective immediately.


