في إطار سعي المجلس القطري للتخصصات الصحية على مواكبة التطورات الإقليمية والعالمية في المجال الطبي وحرصاً من المجلس القطري على توحيد السياسات والإجراءات بما يضمن موضوعية ودقة عملية تسجيل/ ترخيص الممارسين الصحيين في دولة قطر، وبناءً على قرار مجلس إدارة المجلس القطري للتخصصات الصحية في الاجتماع الحادي عشر المُنعقد بتاريخ 2016/12/13، فقد تم اعتماد قائمة شهادات الاختصاص المُحدثة من قبل المجلس القطري في مجال الطب البشري (مرفق) والتي تم تحديثها بعد دراسات مُوسعة لتضم عدد كبير من شهادات الاختصاص المُعترف بها من الكثير من دول العالم مقارنةً بالقائمة السابقة وذلك مع مراعاة جودة المؤهلات والشهادات المُضافة.

كما أن المجلس القطري للتخصصات الصحية يسره أن يُعلن عن إضافة مسميات جديدة في مجال الطب البشري لتصبح المسميات المعتمدة كالتالي:-

- طبيب مُقيم
- طبيب زمالة
- طبيب عام
- طبيب عام (تخصص مُعين)
- إخصائي
- استشاري مُشارك
- استشاري

وفي هذا السياق فإن المجلس القطري للتخصصات الصحية يود التنويه عن أن العمل وفقاً لقائمة شهادات الاختصاص المُحدثة سيتم على مرحلتين؛ كالتالي:-

- المرحلة الأولى: يتم تطبيق القائمة المُحدثة على طلبات التقييم التي لا تزال تحت الإجراء من قبل المجلس القطري بالإضافة إلى طلبات التقييم الجديدة، وذلك وفقاً للمسميات المُعتمدة في مجال الطب البشري كما هو موضح أعلاه، علماً بأنه سيتم تطبيق المرحلة الأولى من تاريخ إصدار التعميم.
- المرحلة الثانية: الأطباء الذين قد تم تقييم طلباتهم قبل اعتماد القائمة المُحدثة ومن ثم تقدموا بطلبات منح الترخيص بالإضافة إلى الأطباء المُرخّصين سابقاً والذين قد أصبحوا مؤهلين للحصول على مسميات مُختلفة وفقاً للقائمة الجديدة، فبإمكانهم تقديم طلبات "تغيير مجال العمل" وذلك بعد شهرين من تاريخ إصدار هذا التعميم.

## No: 1 Policy Statements

- Listed below are the current approved physician`s specialty qualifications in the state of Qatar.
- Qualifications /Certificates not included in the list or from countries other than the below mentioned will be evaluated as per the physician evaluation policy/guidelines.
- The Specialty Qualification Certificate should be issued by Medical Colleges/Universities

### Definition:

In determining the eligibility of an applicant for registration with QCHP as Consultant, Specialist or GP/ special interest, the following definitions for each category to be considered:

#### **Category 1:** Holders of these certificates can:

- a. Get the **Specialist title** without work experience post qualification degree, unless number of years of experience required is specified.
- b. Get the **Consultant title** after completion of one year of work experience post qualification degree.

#### **Category 2:** Holders of these certificates can:

- a. Get the **Specialist title** after completion of one year of work experience post qualification degree, unless more years of experience is specified (If the applicant has less than one year of work experience post qualification degree, he/ she will be eligible for GP/special interest till the required experience is fulfilled then he/ she can change to specialist scope).
- b. Get **the Consultant title** after completion of four years of experience post qualification degree in addition to recommendation letter/s.

OR

#### **For Candidates holding the certificates with asterisk \*\***

- a. Get the **Specialist title** after three years of work experience from post qualification degree, unless more years of experience is specified.
- b. They are not eligible for a **Consultant title** unless a higher qualification is obtained.
- c. If the applicant has less than the required years of work experience post qualification degree he/ she will be eligible for GP/special interest, working under supervision of a licensed specialist in the same/or related branch till the required experience is fulfilled then he/ she can change to specialist scope.

#### **Board Eligible Category (Only for HMC, PHCC and Sidra Medical & Research Center)**

- 1- Board eligible physicians are defined as - "Physicians who:
  - Are Qatari nationals or permanent residents of Qatar;
  - Graduated from any of the medical school(s) approved by/ in the State of Qatar;

- Completed a training program that is accredited by ACGMEI or equivalent in the State of Qatar or abroad;
- 2- Board Eligible physicians will be registered & licensed as “**Associate Consultant**” and will be granted a grace period not exceeding 5 years to complete the exam and be ‘Board Certified’.
- 3- Physicians, who get Board certification within the 5 years grace period, will be entitled to **Consultant** or as per the category of the certificate as well as QCHP guidelines.
- 4- Physicians, who didn’t get Board certification, within the grace period, will not be eligible for “**Associate Consultant**” and will be registered and licensed as GP with special interest as per the area of specialty.
- 5- Board Eligible physicians will be working under supervision of consultants.

**Note:**

- **A waiver of one year from the experience required to Consultant scope will be granted for holders of recognized Fellowship program.**
- **Qatari Physicians and Physicians who completed a training program that is accredited by ACGMEI or equivalent in the State of Qatar and are Board Certified; are exempted from post qualification experience to obtain the "Specialist" scope.**

**Note:** In case of any Governmental agreements with any country that are not included in the list, specialization degree/ certificates can be assessed based on the agreement.

- ❖ The above table is used for regulation purpose and QCHP doesn't interfere with the recruitment process or grading scale of the physicians.
- ❖ QCHP reserves the right to ask for recommendation letters and complete the assessment through the expert panels.
- ❖ QCHP reserves the right to conduct interviews as part of the evaluation process if required.
- ❖ QCHP has the right to ask for additional supporting documents whenever needed.

- ❖ Holders of any post-graduate degree that isn't included in the above table must submit his/her transcript and program curriculum or equivalent subject for review according to QCHP's policies and procedures.
- ❖ In determining the eligibility of an applicant for registration in Specialty Scope, applicant shall comply with the following basic requirements:
  1. To have a minimum of six (6) years undergraduate degree (MBChB/MBBS/MBBCh /Northern American MD or equivalent)
  2. Successful completion of internship program (one year program) where it is applicable.
- ❖ QCHP reserves the right to consult an expert panel in the respective specialty whenever required.
- ❖ Physicians cannot be registered with double specialties unless they are related, but can get privileges for more than one specialty after assessment through a specialized committee.
- ❖ This policy cancels any previous policies in this regard.
- ❖ The applicant must be reasonably fluent in either Arabic or English or both.

#### **No. 4: Certificates That Will Not Be Professionally Classified**

- Certificates of mostly academic nature and character, the curricula of which do not include patient care, clinical practice and practical training in the field of specialization.
- Health Certificates acquired through honorary training programs or as a visiting physician or a non-practicing associate or those which are obtained through correspondence or similar.
- Online Qualification Certificates.
