# تهديكم إدارة التّخصّصات الصّحيّة بوزارة الصحة العامة أطيب تحية وتقدير

وانطلاقا من مساعي إدارة التخصصات الصحية وجهودها المستمرة لتوحيد وتنظيم عمليات التسجيل والترخيص بما يتماشى مع المعايير الدولية، طوّرت الإدارة سياسة جديدة لتسجيل وترخيص أطبّاء الأسنان في اختصاص العلاج التّرميمي.

تهدف هذه السياسة بشكل رئيسي إلى تحديد الامتيازات الفرعيّة لأطبّاء الأسنان في هذا الاختصاص وبالتّالي تسهيل مسار التّسجيل للمتقدّمين منهم لهذا المجال.

# يرجى ملاحظة ما يلي في السّياسة المرفقة بخصوص أطبّاء الأسنان العامّين المرخّصين حاليّاً من حاملي الشّهادات العليا في اختصاص العلاج التّرميمي:

- َ. أطباء الأسنان الّذين لديهم سنوات الخبرة المطلوبة في مجال الاختصاص (حسب فئة الدّرجة الّتي يحملونها) **وليسوا في انقطاع من الممارسة:** يمكنهم التّقدم مباشرة بطلب لتغيير نطاق ممارستهم إلى اختصاصي علاج ترميمي، وذلك بتقديم جميع المتطلبّات (بالإضافة إلى الامتحان التّأهيلي في اختصاص العلاج التّرميمي لحملة الدّرجات من الفئة الثّالثة).
  - 2. أطباء الأسنان الذين لديهم سنوات الخبرة السّابقة في مجال الاختصاص (حسب فئة الدّرجة الّتي يحملونها) لكنّهم في انقطاع من الممارسة: سيكون لديهم فترة سماح سنة واحدة من تاريخ صدور هذا التّعميم لتغيير نطاق ممارستهم إلى اختصاص علاج ترميمي بإحدى الطّرق التّالية (بالإضافة إلى الامتحان التّأهيلي في اختصاص العلاج التّرميمي لحملة الدّرجات من الفئة الثّالثة): أ. العمل خارج دولة قطر لتوفير سجل الحالات المطلوب.
    - ب. تغيير نطاق الممارسة لمساعد اختصاصي علاج ترميمي بغض النّظر عن نوع الكفالة في بطاقة الإقامة القطريّة لتوفير سجل الحالات المطلوب.
      - ج. التّقديم للامتيازات الفرعيّة حسب إرشادات إدارة التّخصّصات الصّحية والعمل بها لتوفير سجل الحالات المطلوب.
- 3. أطبّاء الأسنان الّذين ليست لديهم سنوات الخبرة المطلوبة في مجال الاختصاص (حسب فئة الدّرجة الّتي يحملونها): لا يمكنهم التّقدم بطلب لتغيير نطاق ممارستهم إلى اختصاصيّي علاج ترميمي بتقديم سجل حالات كبديل عن الخبرة ويجب عليهم العمل لتوفير الخبرة المطلوبة حسب فئة درجة الاختصاص.

## Policy name: Update on registration / licensing of Restorative specialists

**Validity:** This policy is the main and valid policy until updated, replaced or cancelled by the department of healthcare professionals. Updates, replacements or cancellations of this policy may occur when needed. However, all healthcare practitioners and parties shall comply with this policy.

- **1. Introduction:** In order to improve the efficiency of the registration/licencing process while ensuring patient safety, and to comply with internationally standardised scope of clinical practice in dentistry, and maintain the quality of healthcare services, it has been decided to introduce dental privileges/procedures for the restorative speciality.
- **2. Policy Statement:** Restorative speciality will be granted to eligible dentists after fulfilling all the requirements as per DHP guidelines and regulations, and they will be able to practise the auto-granted procedures\privileges in their respective speciality.

#### 3. Definitions:

- **3.1** Restorative speciality: A speciality for dental treatment of patients that includes repairing and restoring damaged, decayed, or partially\completely missing teeth to improve function, aesthetics, and oral health. It encompasses various areas of dentistry such as endodontics, prosthodontics, operative and periodontics.
- **3.2 Dental procedure\privilege:** refers to any treatment or intervention performed by a dentist or dental specialist to diagnose, restore, or maintain oral health.
- **3.3 Dental specialist:** A licenced dentist who has completed additional education and training in a specific area of dentistry beyond general dental practice. Dental specialists focus on diagnosing, treating, and managing complex oral health conditions related to their expertise.
- **3.4 Core privileges:** The clinical procedures within a speciality that any licenced Dentist (General/Specialist) can perform, which are automatically granted upon licencing.
- **3.5 Non-core privileges:** The clinical procedures within a speciality that any licenced specialist is automatically granted upon licencing within their speciality, and any licenced dentist with special training courses or postgraduate degree, special skills, and experiences in the speciality can apply and attain through DHP regulations.

#### 4. Abbreviations:

- **4.1 DHP:** Department of Healthcare Professions.
- 4.2 GD: General Dentist.
- **4.3 PSV:** Primary Source Verification.

#### 5. Scope:

This policy is an update tocircular no. (19-2016), It applies to all dentists\healthcare facilities requesting a restorative speciality licence for their dental practitioner, according to the policies applied by DHP.

#### 6. Guidelines:

#### **Evaluation requirements:**

#### Based on DHP guidelines for dentists, the following are required to be evaluated as restorative specialists::

- **Educational requirements:** Applicants holding one of the below certificates shall apply for evaluation as restorative specialists provided that their degree complies with DHP Dentists' Approved Speciality Qualifications requirements. The duration of the programme must be not less than 2 years clinical training programme in the speciality.
  - · Conservative Dentistry and Endodontics
  - · Conservative Dentistry
  - · Restorative Dentistry
  - · Operative Dentistry

**Note:** Any other related post graduate degree, other than the above mentioned, will be reviewed and considered based on DHP regulations on a case-by-case basis.

- **6.2** Work experience requirements: A copy of the recent work experience certificates in the respective speciality (with issue date), (according to Table No. "1": Dentists' Approved Speciality Qualifications in the State of Qatar as per DHP circular 19/2024).
- **6.3 Registration/licence requirements:** A copy of valid medical/registration licences accompanying the required years of work experience (if applicable)..
- **6.4 Primary Source Verification:** A copy of the completed PSV report, including all the education, recent work experience and licences documents.
- **6.5 Speciality exam requirements:** The applicant must provide a copy of a valid passing exam result for the restorative specialty DHP qualifying exam via Prometric Company. It ismandatory for holders of postgraduate degrees from category three as per DHP circular 19/2024.

#### 7. Privileges and procedures:

Licenced restorative specialists are eligible to perform the following dental procedures in addition to the core procedures of General Dentists:

- 7.1 Conventional root canal therapy (multi rooted teeth).
- 7.2 Non-surgical retreatment (multi rooted teeth).
- 7.3 Multiple unit fixed prosthesis construction (more than one quadrant at a time).
- **7.4** Ceramic veneer preparation/fabrication.

#### Notes:

- For additional privileges not listed above, the specialists can apply for non-core privileges as per DHP regulations.
- Any cases\procedures should be clinically assessed thoroughly, and the complicated cases should be referred to the
  respective specialists.

## 8. Changing Scope of Practice to Restorative Specialist

Licenced General Dentists (GDs) who hold a postgraduate degree in Restorative Dentistry may apply to change their scope of practice to Restorative Specialist under the following conditions:

### 8.1 Dentists not in break from Restorative practice

Dentists who are not on break from restorative practice can apply directly for a change of scope to specialists, provided that they meet all requirements based on their degree category

#### 8.2 Dentists in Break from Restorative Practice

Dentists who have the required licenced experience but are currently in break from restorative practice have a oneyear grace period from the date of this policy to change their scope through one of the following options:

## **Option 1: Experience Outside Qatar**

- Submit proof of at least eight weeks of licenced practice outside Qatar (can be continuous or interrupted), within the grace period.
- Provide a logbook signed and stamped by the facility, covering the required non-core procedures.
- The experience, health licence covering the experience and logbook should be verified by PSV company.

#### **Option 2: Assistant Specialist Pathway**

- Change scope from GD to Assistant Restorative Specialist (irrespective of QID sponsorship).
- Work under supervision for up to 4 months to complete the required logbook, within the grace period.
- Refer to Circular No. DHP/2024/19 for assistant specialist requirements and framework.
- After 4 months, supervision must end, and the dentist must either: Change scope to Specialist or Revert to GD (if requirements are not met).
- All other application requirements must be fulfilled (including passing the qualifying exam for Category 3 degrees).

#### **Option 3: Non-Core Privileges**

· Apply for non-core privileges and work with them to complete the logbook within the grace period.

# **Logbook Requirements:**

The logbook must include the following minimum number of complete cases:

- 10 cases: Conventional root canal therapy (multi-rooted teeth)
- 5 cases: Non-surgical retreatment (multi-rooted teeth)
- 4 cases: Multiple unit fixed prosthesis (more than one quadrant)
- 4 cases: Ceramic veneer preparation/fabrication

# 8.3 Dentists Without Required Experience

- Dentists who lack the required two years of experience (based on degree category) are not eligible to submit a logbook as a substitute for experience.
- They may apply for non-core privileges OR as Assistant Specialists (if applicable) and gain experience accordingly OR fulfil the required experience from outside Qatar verified by PSV company.
- **9.** After the termination of one-year grace period, the logbook as a substitute for experience will not be accepted. Hence, licenced GDs must fulfil the required years of experience in the speciality in order to change their scope to specialist, through one of the following options:
  - **9.1.** Apply for non-core privilege in the restorative speciality.
  - **9.2.** Apply as assistant specialist based on QID sponsorship. Please refer to Circular No (DHP/2024/19) for assistant specialist requirements.
  - **9.3.** Provide the required experience from outside Qatar along with its PSV report. Please refer to appendix 2 for a flowchart describing all the above points under 8 & 9.

#### 10. Important notes:

- **10.1** All currently licenced restorative specialists can perform the listed non-core privileges.
- **10.2** All dentists who are willing to apply for restorative speciality after the date of issuance of this policy must fulfil the work experience requirements for specialists in the evaluation application in addition to other requirements.
- **10.3** Dentists who were previously granted certain privileges in any other scope may retain these privileges, in addition to the newly added procedures of restorative speciality as per this policy upon changing scope to specialists (Ref. point 7).
- **10.4** The acceptance of a logbook as a substitute for the experience requirement shall be permitted only during the one-year grace period from the date of issuance of this policy.
- **10.5** Assistant specialist holding facility sponsored QID must change their scope to specialist after completion of four months of supervised practice, OR change their scope to GDs if they did not fulfil the required logbook.
- **10.6** General dentists licenced before 15 March 2023, who are entitled to perform ceramic veneers, may provide a logbook including the required number of ceramic veneer cases from their previous experience upon change scope of practice to specialists based on their post graduate degree, in addition to the other procedures.
- **10.7** The provided logbook must be in DHP template. Please refer to Appendix 1.
- **10.8** Periodic Audits will be held by DHP for licenced restorative specialist clinical practice; any malpractice or misconduct will lead to disciplinary decisions against the practitioner and/or the facility.
- **10.9** Exit/Entry reports from the Ministry of interior will be required on case-by-case basis, any discrepancies found in the logbook will lead to disciplinary decisions against the practitioner.


