Please note the following:

- QCHP will continue receiving the manual radiation application issuing/renewing side by side with the electronic process for one month (grace period) from the date of this circular.
- ❖ The council will stop receiving the manual radiation requests issuing/renewing and will be replaced by the electronic processes.
- The E-Radiation license can be easily accessed through the registration/licensing electronic system.
- ❖ The E-Radiation license will be accompanied with a QR code; which can be scanned by mobile devices and smart phones to ensure its integrity.
- ❖ To apply for radiation license the practitioner has to registered/licensed with the QCHP.
- The validity of the radiation license had been extended to two years.
- The Certificate of Physical Fitness and the Radiation Protection Certificate will be valid for two years.
- Practitioners who have radiation license are requested to attach their old radiation license to the renewal application.
- ❖ Upon the approval of licensing/renewal application, the electronic version of the radiation license (printable) will be available.
- ❖ The guideline for using the electronic process is attached for your reference.





2. Search for the practitioner and click "Show requests".


